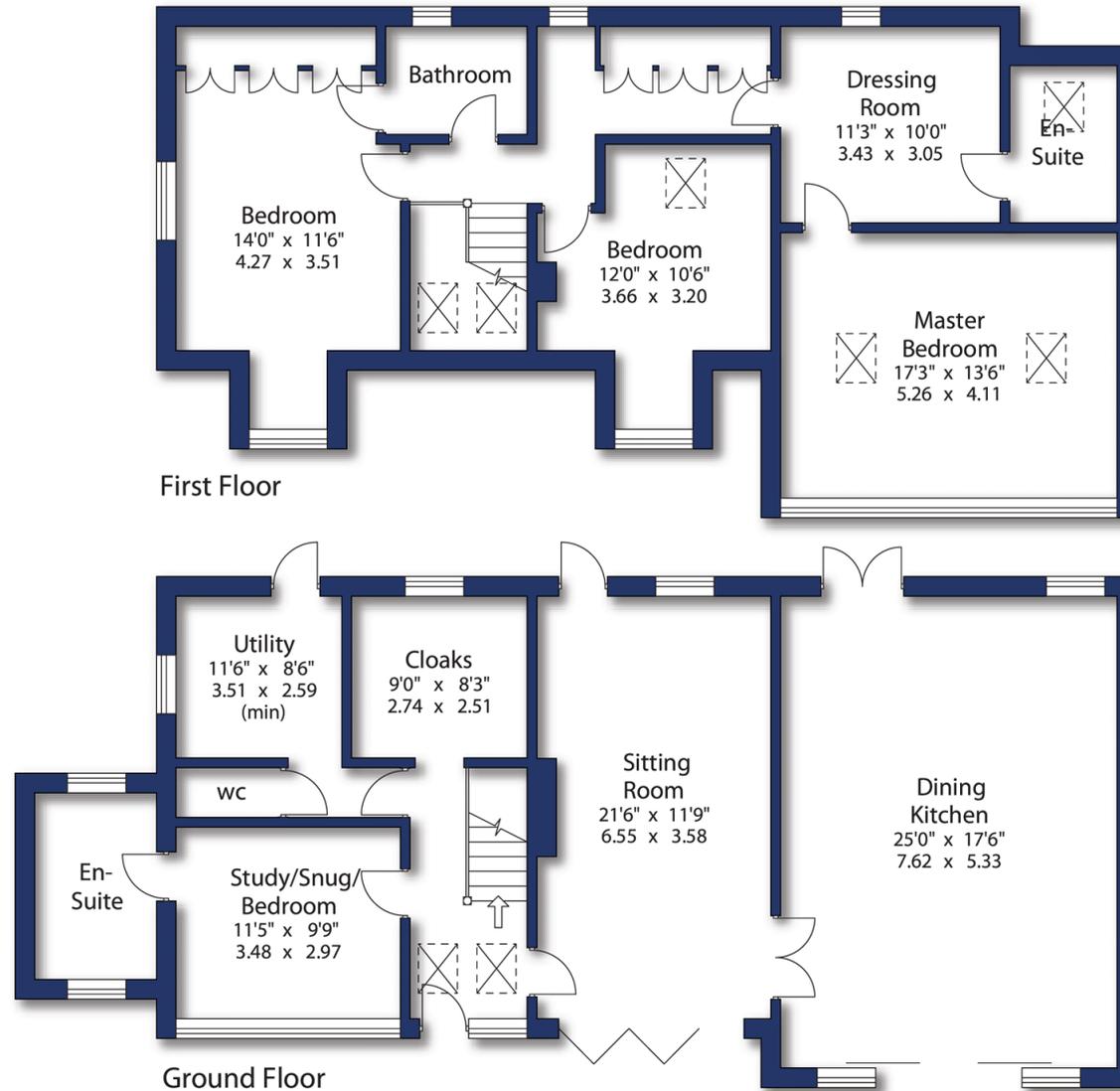
Entry into the full height hallway with high grade flooring and open to a cloakroom with a window to the rear. Into the sitting room with a multi fuel stove, two feature radiators, window and door to the rear and folding doors to the front overlooking the garden.

The bespoke kitchen made by Dalesmade of Settle offers a selection of wall, drawer and base units with a double Belfast sink, an island unit with cupboards, marble worktop, a dresser style cupboard, an integrated dishwasher, space for an American style fridge/freezer, Karndean style flooring with under floor heating, space for an Everhot electric stove, wood flooring, French doors and window to the rear and sliding doors to the front overlooking the garden. The snug/bedroom has a window to the front, high grade flooring and an en-suite with white three piece suite comprising of, a shower with rain hood and attachment, concealed cistern w.c., wash hand basin, laminate flooring and windows to front and rear. The utility room provides fitted units, sink, space for a washing machine and dryer, heated towel rail, laminate flooring, a door to the rear and a window to the side. Also off the utility room is a two piece suite w.c. with a wash hand basin with vanity unit, a close coupled w.c., a heated towel rail and laminate flooring.

To the first floor landing with a window to the rear and two Velux windows. The master bedroom has full height windows overlooking the garden to the front, under floor heating, two Velux windows, a feature radiator and a dressing room off here with a window to the rear and high grade flooring. Also, with a white three piece en-suite comprising of a shower with rain hood, w.c., wash hand basin with vanity unit below, tiling and a Velux window. Onto bedroom two with a feature radiator, loft storage, window overlooking the garden to the front and a Velux. Bedroom three includes fitted wardrobes and cupboards, eaves storage, loft storage, feature radiator and a window to the front and side. Next, the family bathroom with white suite comprising of a bath with rain hood shower over, a vanity unit with wash hand basin, close coupled w.c., laminate flooring and a window to the rear.

Externally to the front is a good sized lawn, stone paved patio, decked area and a tarmac driveway with gates onto Shires Lane. To the side is a paved seating area and to the rear there is a second long concrete driveway with gates to side road and access to the garage which has side opening doors, log store to the side and benefits from power and light.
